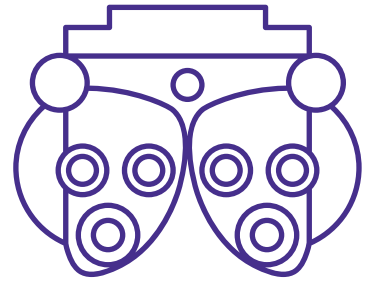

## Patient benefits and prior authorizations

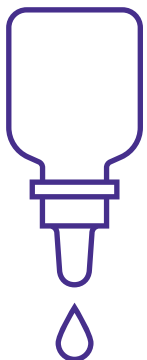

## Dispense with confidence

View patient benefits and prior authorization details at time of dispense and receive alerts when there is a risk you may not be reimbursed for a dispense. Dispense alerts help to monitor treatment intervals, diagnosis code rules by payer, and patient-specific medications. Choose which eye gets treatment, even record a dispense to a previous date.

## Identify billing errors

Don't wait for denials or incorrect payments. Identify mistakes the moment they occur with our billing accuracy reports. PODIS Plus automatically reconciles dispense data with billing data from your practice management system and calls out discrepancies.

# The power of reporting with PODIS Plus

**PODIS Plus offers a wide range of real-time reports to help manage important aspects of your practice. Reports can be exported to Excel for further analysis.**

**Financial reports** help you identify unbilled or misbilled doses, profit per dose, and the value of your current inventory. You can manage all pending and completed payments, and track amounts owed to vendors, whether or not you've received insurance or patient payment. With integration, you can even compare dispenses tracked in PODIS Plus to charges and payments in your practice management system.

**Management reports** let you track the use of PODIS Plus by staff, including placing of orders, dispensing product, and payment of invoices.

And with **inventory reports** you can view on-hand inventory counts and valuations across locations in real-time and see that same information for dates in the past. Track all dispensed doses over time, including patient and assignment date. Even set thresholds per drug and receive alerts when it's time to reorder the product.



# Your daily support system

**The sophisticated alerting tools in PODIS Plus can provide an invaluable failsafe for you and your practice.**

**Patient alert:** indicates if a Patient Assistance Program patient is accidentally being dispensed a billable dose, and vice versa.

**Diagnosis alert:** indicates if a dose is being dispensed for a diagnosis that the patient's insurance might not cover.

**Drug Expiration alert:** indicates if a dose is expired. And also indicates if a dose is being dispensed when there are other doses closer to their expiration dates.

**Minimum interval alert:** set an alert warning for when the same drug – or same kind of drug – is being dispensed within a certain period of time. This is to protect against reimbursement being denied due to certain insurers' rules regarding frequency of treatment.

As an example, this is how the minimum interval alert works:

- 01 You dispense a drug to a patient.
- 02 The patient returns at a later date for a follow-up injection.
- 03 PODIS Plus alerts you if not enough time has passed.
- 04 You take the appropriate action: dispense anyway, or reschedule the patient.

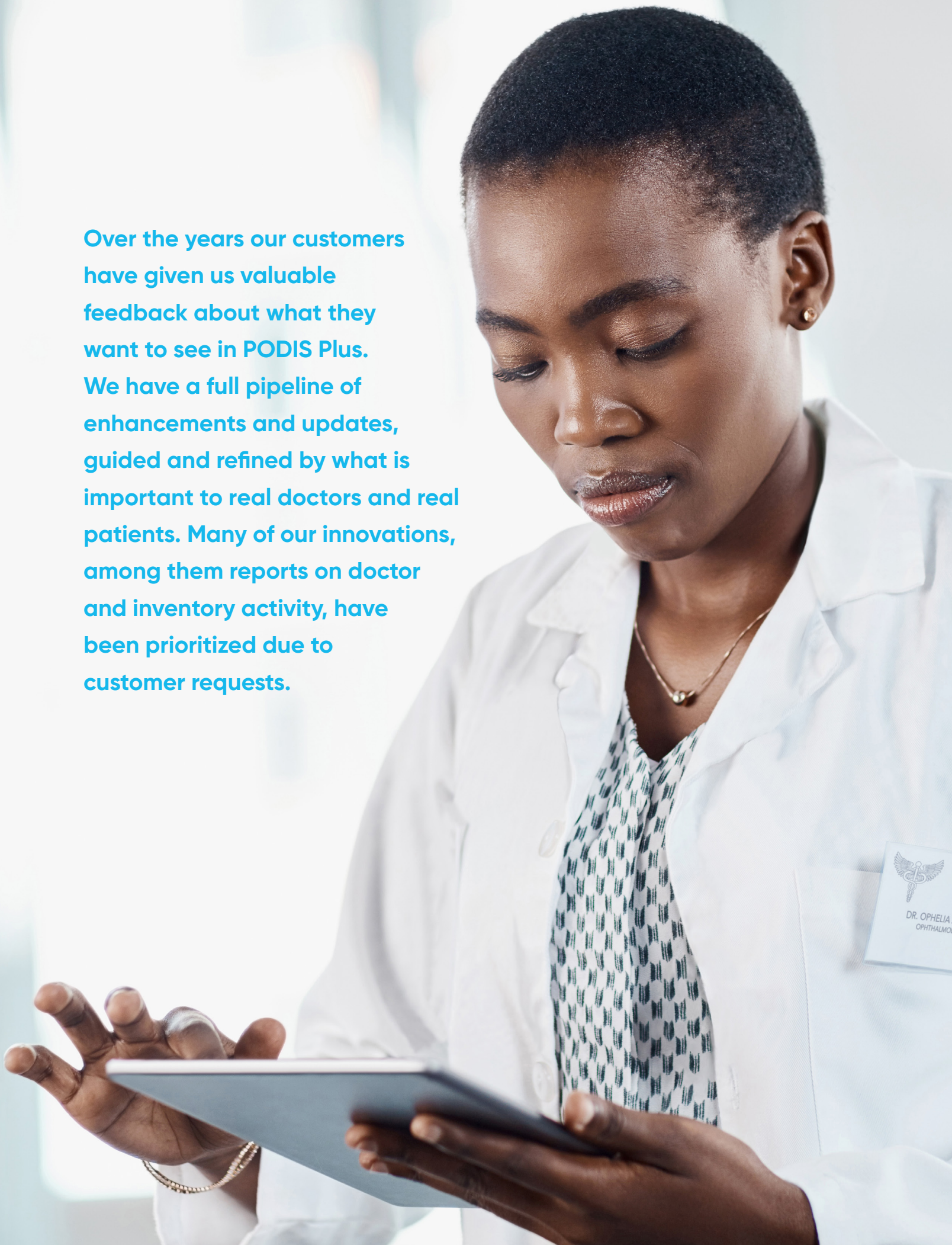

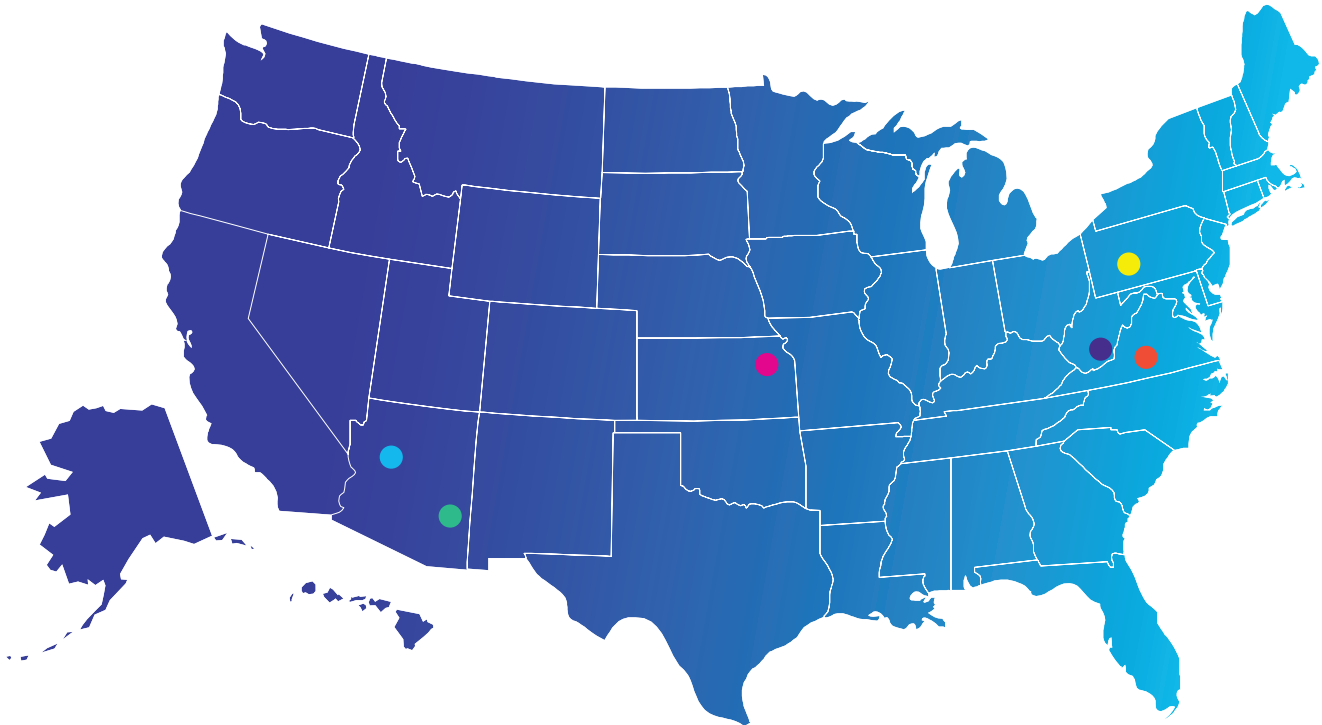
